The appellant most humbly submits the instant Memorandum of Appeal as under on following facts and grounds-

This appeal is against the order of Additional Commissioner, Division Ujjain, Ujjain dated 28.4.2003, which is within a period of limitation. The appellant is aggrieved by the said impugned order, hence this appeal. The facts in brief leading to this appeal are as under:

The appellant submitted an application u/s 131 of Land Revenue Code before the court of Tehsildar, Javad alleging there in that the respondent has encroached upon the open land of the appellant and thereby has attempted to construct a house. On account of such illegal construction by the respondent the way and passage, which the appellant has been using for the last 30 years, is blocked and the such situation has arisen that the bullock cart of the appellant can not pass from the said passage. The original application is dated 8.1.96, the copy of which is enclosed herewith marked as Annexure A-1. Further the Hon'ble court of Tehsildar, allowing the prayer of the appellant passed an interim order dated 30.5.92 by which the respondent was restrained from making further construction. The copy of the said order dated 24.3.2003 was passed is enclosed and marked as Annexure A-2. Subsequently the final order was passed and the appellant was prevented to lead the evidence which is, Annexure A-3. On many of the dates the
