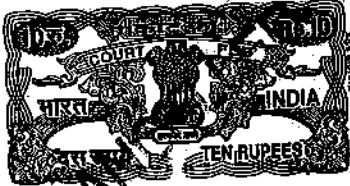

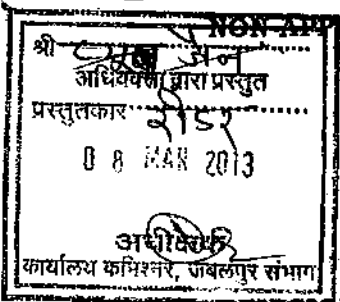

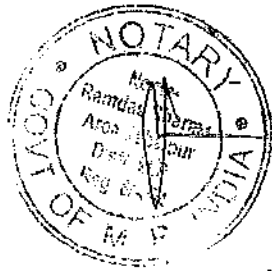

1. That the applicants have preferred this revision against the order dated 31.10.2012 (copy delivered on 18.1.2013) passed by the Tehsildar Balaghat whereby the learned Tehsildar has stalled up the proceedings of Mutation in respect of land situated in village Gaaykhuri Tehsil & District Balaghat Khasra No. 187/1Kha & 187/3. A certified copy of the order of Tehsildar is marked here as **ANNEXURE-P/1**.
2. That the applicants purchased a land measuring Rakhba 0.546 Hectares having Khasra No. 187/1Kha & 187/3 situated in village Gaaykhuri Tehsil & District Balaghat from Shri Omkar Katare vide registered Sale deed dated 14.7.2011.
3. That the applicants thereafter applied for mutation before the learned Tehsildar. In the meantime the non-applicants herein, the son-Rakesh Katare & daughter- Madhuri Katare of the seller (Omkar Katare) filed a suit in the court of IV<sup>th</sup> Civil Judge Class-II, Balaghat which was registered as Civil Suit no. 129A/2011
