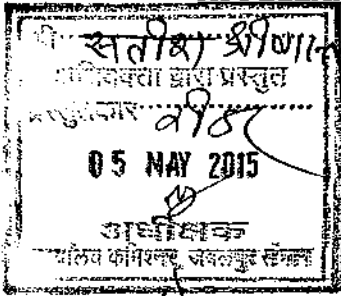

**APPEAL UNDER SUB SECTION (4) OF SECTION 35 OF MADHYA
PRADESH LAND REVENUE CODE 1959**

The appellant named above most humbly preferred this appeal well within the period of limitation against the Order Dated 30th March 2015 passed by the learned Additional Divisional Commissioner Jabalpur Division Jabalpur in Case No. 653/A-27/10-11 Parties being Satish -Applicant Versus Radhe Shyam and others, rejecting an application under Section 35(3) of M.P.L.R.Code filed for set-aside the Order Dated 04.09.2013 and restoration of the Second Revenue Appeal No.653/A-27/10-11 Parties Being Satish Versus Radhe Shayam Bagri & Others.
