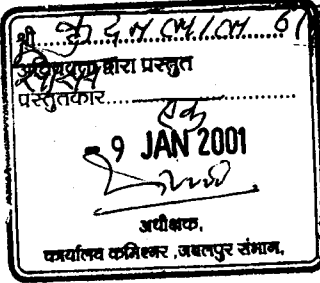

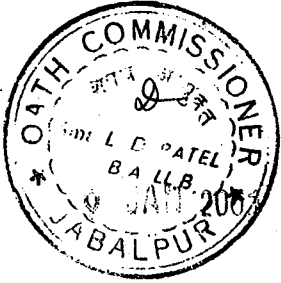
REVISION UNDER SECTION-50 M.P.LAND REVENUE CODE:

97-98, on the following facts and grounds :-

F A C T S

1. That on 16-3-59 patta was allotted to the father of the applicant Chhotelal of Kh.No.85 of village Rosara. After the allotment of patta, in some of the land, the applicant's father constructed pakka residential and some part of land lying vacant as Baadi.
2. After the death of the father, the applicant came in possession as owner of the aforesaid property, and he has paid rent to the Janpad Panchayat Narsinghpur, uptodate.
3. The respondents have taken forcible possession of the vacant land attached to the house of the applicant. And started making a construction of wall, hence applicant applied for demarkation, and demarkation was done by Patwari.
