**FACTS OF THE CASE :-**

1. That, The original permanent lease of Nazul Land bearing Plot No.10, Block No. 45 Chhindwara was duly transferred to the predecessor entitled of the appellant on 4<sup>th</sup> January 1999. The appellant purchased 2400 Sq. Ft. of land out of plot No. 10 of Nazul Block No.45 situated in Chhindwara through registered sale deed which was executed by Smt. Saroj and others. This land in question was duly diverted for residential purpose vide case no. 164/A-20(4)/1992-1993. The appellants name was duly substituted and permanent patta was granted to the appellant in pursuance of the order passed in case no. 14/A-20(1)/2000-2001, dated 22/06/2001.
2. That, unexpectedly on 01/07/2001 the Additional Collector, Chhindwara issued show cause Notice to the appellant as to why the order relating to renewal of lease should not be reviewed.
3. That, the appellant filed his preliminary objection on 09/07/2001 before Additional Collector Chhindwara. The Additional Collector, Chhindwara was pleased to order that the preliminary objection shall be decided finally with the final order and the case was posted for 11/07/2001.
4. That, But the case was adjourned to 12/07/2001 on the ground that the Additional Collector, Chhindwara was busy on some other Govt. Work.
5. That, on 12/07/2001, the Additional Collector told the appellant that the orders have been reserved and he may be intimated as and when it is passed.
