1. That, the present review petition is being preferred by the present petitioner aggrieved by the impugned order Dated 12.11.2018 Passed In Case No.707-Two/2017 where by the revision preferred by the respondent herein was allowed and the order passed in favour of the petitioner in the second appeal was set aside.
2. That, the Respondent herein had filed an application under Section 250 of MPLRC before the Tehsildar District Shivpuri. In the said application the Applicant claimed that he is the owner of land which is situated in Survey No. 882 and Survey No. 884 situated in village Maniyar Tehsil and District Shivpuri.
3. That, in his application Applicant claimed that he had constructed a wall over his land situated on the said survey no. and had put a lock on the gate. It was the case of the Applicant that in the month of January 2014, the Appellant/Respondent had broken the lock and by putting a
