The applicant most respectfully submits this revision as under: -

- That, the humble applicant is the owner of the Survey No.146 measuring .07 hectare and the same has been purchased vide sale-deed dated 28.01.1992 from the non-applicant.
- That, for the correction in the revenue entries, humble applicant filed an application before the Tahsildar under Section 115-116 of M.P. Land Revenue code, 1959 and the same was allowed vide order dated 25.07.2012.
- 3. That, against the order dated 25.07.2012, the respondent filed the appeal before the S.D.O. Ambah and the S.D.O. Ambah vide order dated 26.09.2012 allowed the appeal and set aside the order dated 25.07.2012.
- That, against the order dated 26.09.2012, the humble applicant filed the appeal before the Commissioner, Chambal Division, Morena and vide impugned order the appeal was dismissed.
