The material facts for consideration of this revision petition are as under:-

- (01) That the non applicant filed an application No. 22A-6/02-0 under section 109 & 110 of the M.P. Land revenue code 01/04/2003 & States that the agricultural land survey No. 1241/2 Rakba 0.069 Hectare survey No. 1242/2 Rakba 0.952 Hectare situated in Gram Devri Khavasa Tehsil Manasa in the Name of Non-applicant & Petitioner father & a will is executed in favour of him by testator on 4/1/1998 in respect of this land & he become the owner of this land after the death of testator.
- (02) That the petitioner filed a civil suit No. 39A/99 against the non-applicant in the court of civil judge II class Manasa for declaration & injunction & the petitioner admitted the execution of will therefore suit is withdrawn by him & he become the owner of this land according to will of 4/1/1998 & these lands are coming in possession of himself when his father was alive therefore his name should be mutated in revenue record.
- (03) That the petitioner filed the reply of the non-applicants application on 19/05/2002 & accepted that the land is coming in record in father's name but he states that on 04/01/1998 his father never executed a will in favour of non-applicant & the will nor registered nor attested by the notary & it is on blank
