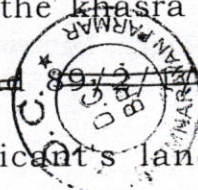

Revision under Section 50 of M.P. Land Revenue Code, 1959 arising out from the Order dated December 04, 2014 passed by Addl. Tehsildar, Tehsil Tappa, Sanchi, District Raisen in revenue Case No.-4/31-6-31/2013-14, titled as Brij Mohan Ram Kali Vs.
