REVISION UNDER SECTION 50 OF M.P. LAND REVENUE CODE 1959

Being aggrieved by Order Dated 23.09.2016, passed in Case No. 787/A-6/13-14 passed by Additional Commissioner, Jabalpur Division Jabalpur (M.P.) the applicant prefer this Revision on the following amongst other facts and grounds:-

FACTS :-

1. The appellant declare that this is the first 'Civil Revision' no other proceeding on the subject matter is filed nor pending in any other court.
2. That the case of the applicant is that the applicant is daughter of late Shri Ram Rajpal @ Rajrajpal Singh Rajput. It is submitted that the deceased Late Shri Ram Rajpal @ Rajrajpal Singh, is the land lord in Bandobast No. 393 of Halka No. 29, Revenue Mandal Shrinagar, Tah- Gotegao, Distt, Narsinghpur (M.P.) of Khasra No. 46/2 are 0.046 Hect., Khasra No. 48/1, 48/2, 49/1, 49/2 & 51/2 area 1.392 Hect., Khasra No. 52, 43, 54 & 55 area 0.166 Hect, Khasra No. 109/2 area 4.928 of village- Babli, Tah Gotegao, Distt.
