Being aggrieved order dated 16/11/2017 passed in Case No. 571/A-27/2013-14 by additional Commissioner Jabalpur Division Jabalpur.

That the petitioners most humbly and respectfully submit as under:-

1. That, the applicant's father late Shri Devrao Dufare filed an application under section 178 M.P.L.R.C. before the court of Tahsildaar- Sonsar, District Chhindwada on 01/03/2002 wherein on 15/04/2002 late Shri Devroa Dufare gave his statement on oath alongwith applicant no.1 statement and by order dated 06/04/2002 in case No. 12/A-27/2001-02 Tahsildar-Sonsar Partition the land which is reproduced below for the sake of convenience of the court.

2. Thereafter applicant no.1 filed an application under section 178 M.P.L.R.C. Before the Tahsildar- Sonsar to partition the land which he was received from his father in the above mentioned case and by order dated- 08/08/2011 in Revenue Case No.80/A-27/2010-11 partition the land between the Applicant's No. 1, 2 & 3.
3. That after a long delay, respondents filed an appeal before the Sub-Divisional Officer S.D.O. Sonsar District Chhindwada, M.P. against the order dated 08/08/2011 passed in Revenue Case No. /80/A-27/2010-11. It is pertinent to mention here that to respondent never challenged the order dated 06/04/2002 and directly filed the appeal against the partition order 08/08/2011. That by order dated 13/02/2014 S.D.O. Sonsar dismissed the First Appeal.
4. That being aggrieved by the order dated 13/04/2014 respondents filed Second Appeal No. 571/A-27/2013-14 before the Additional Commissioner




